

Privacy Policy

We at BI Analytics Fintech are committed to protecting your privacy. This Privacy Policy describes the ways in which we, collect, hold and use information about visitors to this website.

What are the Personal Information that we collect and process?

For the purposes of this privacy statement, 'Personal Information is any data which relates to an individual who may be identified from that data, or from a combination of a set of data.

In general, you may browse our website without revealing any information about yourself. However, certain information such as your IP address may be collected in order to measure the number of visits, average time spent on the site, pages viewed, etc.

When you register on our website or would like to comment on our content, we may require you to provide us with certain Personal Information such as your Name, Email address, Designation, Company, Country and Phone number, etc for one or more of the following purposes: identifying you, contacting you and provide access to desirable content based on your preferences.

BI Analytics Fintech products and services are intended for a general audience and are not directed to children under the age of sixteen (16). As such we do not knowingly collect, use, solicit or disclose personal information about visitors less than 16 years of age. If you are under the age of 16, we ask that you do not access the Websites. How do we use the information that we collect from you?

BI Analytics Fintech would use the information shared by you, to respond to business inquiries from you.

To provide information based on your need: Based on your selection to subscribe or register to our Newsletter etc. We would use your personal information to periodically send you the corporate newsletter and share with you, updates on our services.

To improve the quality and usability of the websites: BI Analytics Fintech would use the personal information that you share, including information regarding the site navigation, to improve the website, enhance page response time, and improve the usability of the website.

To communicate with you about the events that we organize: We would use the personal information that you share on the website, including on the event registrations page, to communicate with you about events that we organize or participate in. We would also request your personal information at the venue of such

event that we host, visit or participate. Personal Information collected by BI Analytics Fintech at the venue of events that we host, visit or participate in will also be subject to this policy. At the venue of events that we host, visit or participate in, as the pages on this website, you may share personal information at your own discretion.

When you visit our Websites we may send a 'cookie' to your computer. Cookies are files that store information on your hard drive or browser. They enable our Websites to identify your computer and recognize that you have visited before. Cookies themselves do not contain any personal information. However, we may link the information we store in cookies to any personally identifiable information you submit while on our site. Cookies help us understand which sections of our Websites are the most popular, as they help show which pages are being visited and how long for. This helps us to adapt our Websites to provide more relevant and accessible information. You may configure your browser to accept all cookies, reject all cookies, or notify you when a cookie is sent. Please note, however, that disabling cookies might affect your online experience and/or prevent you from taking full advantage of our site.

What control do you have on the information that we collect?

You may request us to stop using your details for marketing and other promotional activities by using the unsubscribe method provided in our various communications.

If you choose to withhold any Personal Information requested by us, it may not be possible for you to gain access to certain parts of the website and for us to respond to your query.

How will you know if the Privacy Policy has changed?

BI Analytics Fintech would update our Privacy Policy as and when needed. If we make any material changes, we will notify you by means of a notice on this website, prior to the change becoming effective. We encourage you to periodically visit this page for the latest information on our privacy compliance. In any case, our commitment to protecting the privacy of website users will continue to remain.

Data recipients, transfer, and disclosure of Personal Information:

BI Analytics Fintech will seek your consent prior to using or sharing Personal Information for any purpose beyond the requirement for which it was originally collected.

We may share your Personal Information within our affiliates, business partners, service vendors, authorized third-party agents, or contractors located in any part of the world for the purposes of data processing, storage, or to provide a requested service or transaction, after ensuring that such entities are contractually bound by data privacy obligations.

When required, BI Analytics Fintech may disclose Personal Information to external law enforcement bodies or regulatory authorities, in order to comply with legal obligations.

Data security

The security of your information is important to us. BI Analytics Fintech has implemented reasonable technical and organizational security measures to protect your Personal Information against unauthorised access, accidental loss, improper use and disclosure. We will also take all reasonable precautions to ensure that our staff and employees who have access to information about you have received adequate training.

Data retention

We shall not keep your personal information for any longer than necessary to fulfil our obligations to you or to meet our legitimate business interests or legal requirements.

Privacy Preferences

No Sale of Personal Data
